Please provide details of the existing, and proposed, road lines and levels.

Third party land

If the proposed main is likely to be routed through land which you do not own, we need written confirmation of the landowner's name and address so that we can service the appropriate notices. Failure to provide these details may lead to delays in laying and commissioning the main.

Environmental issues

Please tell us about any environmental constraints identified during the planning stage. Failure to provide details of environmental issues or conditions imposed by the planning authority may lead to delays in laying and commissioning the main.

CDM

Where sites are subject to Construction (Design and Management) Regulations 2015, you need to tell us who the principal designer is, so that we can pass on any health and safety information included in the Health and Safety File.

Application and design fees

You'll need to pay upfront, non-refundable application and design / checking fees, which cover our initial costs including administration and preparation of your quote and finalising the technical solution required.
