## Strategic Report

The Directors present their Strategic Report for Thames Water (Kemble) Finance plc (“the Company”) for the year ended 31 March 2023.

### Review of the business and strategy

The Company was established to make certain financing arrangements on behalf of its immediate parent undertaking Kemble Water Finance Limited (“KWF”), and this remains unchanged from the previous year.

The Directors consider the ultimate parent undertaking to be Kemble Water Holdings Limited (“KWH”) and the largest group consolidating the Company is the Kemble Water Holdings Limited Group (“the Group”). This remains unchanged from the previous year. The Company is not individually managed but rather managed as part of the Group as a whole on an inclusive basis.

During the year, the Company raised no new debt (2022: £nil). In July 2022, £118.5 million was received from KWF as repayment of an intercompany loan together with accrued interest; and used to repay £115.1 million of external debt and £3.4 million of related interest. At 31 March 2023, the Company had in issue £400.0 million (principal) of listed debt (2022: £515.1 million) in the form of secured bonds.

In March 2023, Fitch downgraded KWF’s and the Company’s senior secured debt rating to B (2022: B+) and KWF’s Long-Term Issuer Default Rating to B with negative outlook (2022: B+ with negative outlook). In March 2023 Moody’s affirmed the rating of the Company’s senior secured debt at B1 and changed the outlook to negative (2022: B1 with stable outlook).

### Results and performance

The Directors have determined that the profit on ordinary activities before taxation and the net assets are the most appropriate key performance indicators for an understanding of the development, performance and position of the Company.

For the financial year ended 31 March 2023, the Company made a profit on ordinary activities before taxation of £391,000 (2022: £409,000), a reduction of £18,000 compared to the previous year mostly attributed to other finance fees not recharged to KWF. Financing costs arising from raising funds on behalf of KWF are recharged to KWF through intercompany loans with an annual margin of £10,000 (2022: £10,000) and a 0.10% margin on the £400.0 million intercompany loan. Net assets of the Company at the financial year ended 31 March 2023 were £884,000 (2022: £547,000). On this basis the Directors have no significant concerns regarding the performance or position of the Company.

### Principal risks and uncertainties

The Company’s operations expose it to a variety of capital and financial risks. The Group’s treasury operations are managed centrally, by a specialist team which operates with the delegated authority of, and under policies approved by, the Group’s Board of Directors, therefore, risks are managed on a Group wide basis.

The operation of the treasury function is governed by specific policies and procedures that set out specific guidelines for the management of liquidity, credit and market risks associated with the financing activities of the Group. The key elements of the treasury policies and procedures are incorporated in the Group’s annual report and consolidated financial statements.

Copies of the Group’s annual report and consolidated financial statements may be obtained from The Company Secretary’s Office address mentioned in Note 12.

## Strategic Report (continued)

### Principal risks and uncertainties (continued)

#### *Capital risk management*

Capital risk relates to whether the Company is adequately capitalised and financially solvent. The key objectives of the funding strategy are to retain the credit rating of the Company's debt and provide liquidity sufficient to fund ongoing obligations. The Board reviews the Company's exposure to these risks and actively oversees the treasury activities, reviewing treasury policy and approving the treasury strategy and funding plan on an annual basis.

The capital structure of the Company consists of borrowings and equity. Quantitative information in relation to the capital structure is included in Note 8 'Borrowings' and Note 10 'Called up share capital' respectively.

#### **(a) Market risk**

Market risk is the risk that changes in market variables, such as inflation and interest rates, will affect the Company's income or the value of its holdings of financial instruments.

Interest rate risk arises on interest-bearing financial instruments. The Company's only external financial instruments are fixed rate borrowings, which are held at amortised cost using the effective interest rate method, to be settled at par on maturity. Debt raised by the Company is on-lent to its immediate parent entity KWF.

#### **(b) Credit risk**

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations and arises solely from the Company's loans to its immediate parent entity KWF.

Credit control policies and procedures are in place to minimise the risk of bad debt arising from receivables including, where appropriate, a review of the budget and forecasts of the counterparty entity, KWF so as to assess its ability to repay debt and pay interest.

#### **(iii) Liquidity risk**

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due. The Group manages long-term liquidity by maintaining continuity of funding through access to different markets and debt instruments, raising funds in the capital markets and ensuring that diverse debt maturity profiles are maintained. The Company matches its financial obligations with receivables due from its parent.

Details of the Company's borrowings and other financial instruments are disclosed in Notes 8 and 9 respectively.

As stated in the accounting policies to these financial statements, the Directors are satisfied that the Company has sufficient resources to continue in operational existence for the foreseeable future, a period of not less than 12 months from the date of this report. Accordingly, they continue to adopt the going concern basis in preparing these financial statements.

## Strategic Report (continued)

### s172 reporting

The Directors of the Company must act in accordance with the duties contained in s172(1) of the Companies Act 2006 as follows:

“A Director of a company must act in the way he considers, in good faith, would be most likely to promote the success of the company for the benefit of its members as a whole, and in doing so have regard (amongst other matters) to:

- (a) the likely consequences of any decision in the long-term;
- (b) the interests of the company's employees;
- (c) the need to foster the company's business relationships with suppliers, customers and others;
- (d) the impact of the company's operations on the community and the environment;
- (e) the desirability of the company maintaining a reputation for high standards of business conduct; and
- (f) the need to act fairly as between members of the company.”

On appointment, as part of their induction of becoming a Director, each Director is briefed on their duties and the availability of professional advice from either the Company Secretary or, if they consider it necessary, from an independent adviser. The Directors of the Company have access to the resources provided to the Directors of the Group's main trading company, Thames Water Utilities Limited.

During the year, the Company has continued to act as a financing company within the Kemble Water Holdings Limited Group. Day-to-day running of the Company is managed by the Company's management team, consisting of employees from the Group's main trading company, Thames Water Utilities Limited. The Company had no employees during the year, or as at the date of this report, nor did it have any external customers or trading arrangements with suppliers.

#### Likely consequences of decisions in the long-term

The Board's decision in the prior year to update the debt issuance programme documentation was consistent with the purpose of the Company being in a position to act as a financing vehicle for its parent. The decision in the prior year to issue £400.0 million of debt due in 2026 enables the Company to earn a 0.10% margin from lending the proceeds to its parent. In the current year, the Company repaid £115.1 million of external debt and £3.4 million of related interest, and no new debt was raised.

#### Stakeholder management

The Company's stakeholders are considered to be external debt investors and other companies within the Kemble Water Holdings Group with whom intercompany loan relationships exist. The Company places considerable importance on communication with investors and through a Group-wide approach, regularly engages with them on a wide range of topics. The Group's Director of Corporate Finance is responsible for facilitating communication with investors and analysts and maintains an active investor relations programme. Wider stakeholder engagement occurs regularly throughout the year, both formally and informally.

#### Community and environment

In raising funding for other Group companies, the Board supports the Group-wide commitment to seeking to continually improve the delivery of water and wastewater services in the most sustainable way, which means complying with regulation, delivering public value and leaving the environment in a better state than we found it at the end of each regulatory period. The Group's Board of Directors manage the Group and further details of how they have carried out their duties is disclosed in the financial statements of the ultimate controlling party Kemble Water Holdings Limited. The Group's annual report and consolidated financial statements is available from the address shown in Note 12.

#### Community and Environment (continued)

The Board of Directors of the Company consider, both individually and together, that they have acted in the way they consider, in good faith, would be most likely to promote the success of the Company for the benefit of its members as a whole, having regard to the stakeholders and matters set out in s172(1)(a-f) of the Companies Act 2006.

#### **Future outlook**

It is expected that the Company will continue with its current business model for the foreseeable future, with the proceeds of the Company's debt raising activities lent to its immediate parent undertaking KWF with a margin charged in addition to the underlying costs.

## Directors' report

The Directors present their annual report and the audited financial statements of the Company for the year ended 31 March 2023. The Directors consider that the annual report and financial statements, taken as a whole, is fair, balanced and understandable, and provides the information necessary for shareholders to access the Company's performance and strategy.

### Future outlook

The future outlook of the Company is discussed in the Strategic Report.

### Going concern

The TW(K)F Directors have considered the nature of the business and do not expect this to significantly change over the next 12 month period, recognising it is a special purpose financing entity with no business operations other than raising external funding for its Guarantor and direct holding company, Kemble Water Finance Limited ("KWF"). TW(K)F relies on Kemble Water Holdings Limited ("KWH"), the ultimate parent company, for ongoing support.

KWH has confirmed that it will continue to provide support to the Company to enable it to meet its liabilities as they fall due for a period of at least twelve months from the date of signing of these financial statements and on this basis the Directors of TW(K)F have adopted the going concern basis in preparing these financial statements.

In making the assessment of KWH's ability to provide the support as required, the Directors of TW(K)F have considered the material uncertainty in relation to the going concern assessment in KWH related to (i) the inability to refinance the £190 million loan facility with KWF (an indirect subsidiary of KWH and the parent company of TW(K)F) before April 2024 and (ii) the breach of the Post Maintenance Interest Cover ("PMICR") covenant for KWF Group in the event of a severe but plausible downside scenario and the availability of or certainty of potential remedies. The KWH Directors have also considered the various options to resolve such uncertainties at KWF which include but are not limited to various refinancing actions which could include additional support from shareholders on a temporary basis. Remedies to address potential non-compliance of the PMICR covenant include utilisation of the associate equity cure via shareholder contributions which underpin the business plan of Thames Water Utilities Limited and the amendment or refinancing of the associated loan facility, both of which require the agreement and support of the loan counterparty. These material uncertainties relating to refinancing requirements and covenant compliance of the KWH Group may cast significant doubt about the ability of TW(K)F to continue as a going concern.

The Directors of TW(K)F, have considered it appropriate to place reliance on the support from KWH despite the uncertainties noted above, based upon a review of the KWH Group's budget, business plan and investment programme, together with the cash and committed borrowing facilities available. The TW(K)F Directors also took into account potential contingent liabilities and other risk factors in making their assessment.

## Directors' report (continued)

### Going concern (continued)

For these reasons, the TW(K)F Directors' have a reasonable expectation that the Company will have access to adequate resources to continue in operational existence for a period of at least 12 months from the date of these financial statements and have therefore concluded that the financial statements should be prepared on a going concern basis. However, the financial statements do not include the adjustments that would result if the Company were unable to continue as a going concern.

### Dividends

The Company paid no dividends during the year (2022: £nil). The Directors do not recommend the payment of a final dividend (2022: £nil).

### Corporate Governance

The Company has full access to the Board of the Group, including access to the risk management and internal control systems. Their system of risk management and internal control aims to ensure that every effort is made to manage risk appropriately, rather than eliminate risk completely, and can only provide reasonable, rather than complete, assurance against material impact. The Group's management of risk supports this through a number of key company level internal controls and responses:

- (i) Business planning, budgeting and forecasting. These activities support resilient operations and sustainable and robust finances. The annual budgeting exercise includes a detailed budget for the year and a view for the remainder of the asset management plan ("AMP");
- (ii) Performance reporting – the Company Board and Group shareholders receive monthly management reports, including an overview of key performance metrics;
- (iii) System of delegated authority – delegated levels of decision making authority are reviewed and approved by the Board;
- (iv) Insurance – insurance programme and insurance team are in place. The Board review and approve the strategic approach being taken to level and type of cover;
- (v) Company policies, standards, guidelines and procedures – relevant governance documentation is reviewed regularly and is intended to manage our inherent risk; and
- (vi) Code of conduct and Whistleblower hotline – code of conduct and confidential whistleblowing processes are in place to be investigated by a dedicated team.

The Enterprise Risk Management and Internal Audit teams also provide reporting and assurance over our management of key business risks.

Further details relating to Corporate Governance are incorporated in the Group's annual report and financial statements.

### Financial risk management

During the year, the Company had access to the Executive Team of TWUL, who also manage the wider KWH Group on a day-to-day basis on behalf of the Directors of individual group companies. They receive regular reports from all areas of the business. This enables prompt identification of financial and other risks so that appropriate action can be taken in the relevant Group companies. The Company's operations expose it to a variety of financial risks which are described in the Strategic Report.

### Research and development

The Company undertakes no research and development activity, this remains unchanged from the prior year.

### Political and charitable donations

No political or charitable donations were made by the Company during the year (2022: £nil).

# Independent auditors' report to the members of Thames Water (Kemble) Finance plc

## Report on the audit of the financial statements

### Opinion

In our opinion, Thames Water (Kemble) Finance plc's financial statements:

- give a true and fair view of the state of the company's affairs as at 31 March 2023 and of its profit and cash flows for the year then ended;
- have been properly prepared in accordance with UK-adopted international accounting standards; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

We have audited the financial statements, included within the Annual report and financial statements (the "Annual Report"), which comprise: the Statement of financial position as at 31 March 2023; the Income statement, the Statement of cash flows and the Statement of changes in equity for the year then ended; the Accounting policies; and the notes to the financial statements.

Our opinion is consistent with our reporting to the Kemble Water Holdings Limited Board.

### Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities under ISAs (UK) are further described in the Auditors' responsibilities for the audit of the financial statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### Independence

We remained independent of the company in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, which includes the FRC's Ethical Standard, as applicable to listed public interest entities, and we have fulfilled our other ethical responsibilities in accordance with these requirements.

To the best of our knowledge and belief, we declare that non-audit services prohibited by the FRC's Ethical Standard were not provided.

Other than those disclosed in note 1 to the financial statements, we have provided no non-audit services to the company in the period under audit.

### Material uncertainty related to going concern

In forming our opinion on the financial statements, which is not modified, we have considered the adequacy of the disclosure made in the accounting policies to the financial statements concerning the company's ability to continue as a going concern.

We note that TW(K)F relies on support from Kemble Water Holdings Limited (KWH) (ultimate parent company) and as at the date of approval of the financial statements there is a material uncertainty relating to going concern at KWH as there are uncertainties relating to (1) the refinancing of the £190m loan facility which is due for repayment in April 2024 at Kemble Water Finance Limited (KWF) (an indirect subsidiary of KWH and the parent company of TW(K)F); and (2) KWF is forecasting to breach the PMICR covenant under a severe but plausible downside scenario. This in turn creates a material uncertainty at TW(K)F as due to the conditions above, it creates a material uncertainty as to whether KWH would be able to extend the support committed if and when required.

These conditions, along with the other matters explained in the accounting policies to the financial statements, indicate the existence of a material uncertainty which may cast significant doubt about the company's ability to continue as a going concern. The financial statements do not include the adjustments that would result if the company were unable to continue as a going concern.

In auditing the financial statements, we have concluded that the directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Our evaluation of the directors' assessment of the company's ability to continue to adopt the going concern basis of accounting included:

- Understanding and assessing the factors creating a material uncertainty and the consequences of an Event of Default (EOD).
- Assessing whether the directors' statement that they have a reasonable expectation that the potential mitigating actions to the material uncertainties will occur is reasonable.
- Obtaining and understanding the terms of the Group's financing and credit facilities. We have verified the existence of the facilities in place on which management has based its liquidity forecast for a period of in excess of 12 months from the date of the approval of the 31 March 2023 financial statements (the going concern period).
- Testing the mathematical integrity of the cash flow forecasts and the models supporting the forecasts used by management to support the underlying going concern assumption and reconciling these to Board approved budgets.
- Understanding the key assumptions management have applied in developing their base case and plausible and severe downside scenarios and assessing their reasonability.
- Performing a comparison of budget versus actual for the year ended 31 March 2023 and understanding where variances had arisen. Through this testing we obtained reasonable assurance over management's ability to forecast accurately.
- Verifying liquidity forecasts to the Board approved budget and testing that contractual debt principal and interest payments had been appropriately included within the forecasts. We validated management's conclusion that there is insufficient available committed funding without any refinancing or raising of new debt or receipt of the shareholder funding to repay the £190m loan facility held by KWF that matures in April 2024.
- Obtaining covenant compliance certificates, confirming that all the key covenants that impact the continued access to finance have been considered over the relevant time periods and verifying the mathematical accuracy, and testing inputs back to either the year end financial numbers or for forecasted information to the Board approved budget.
- Assessing the disclosure given in the financial statements in respect of going concern and whether it gives a fair and balanced view.

Our responsibilities and the responsibilities of the directors with respect to going concern are described in the relevant sections of this report.

## Our audit approach

### Overview

#### Audit scope

- As part of designing our audit, we determined materiality and assessed the risks of material misstatement in the financial statements. In particular, we looked at where the directors made subjective judgements, for example in respect of significant accounting estimates that involved making assumptions and considering future events that are inherently uncertain. As in all of our audits we also addressed the risk of management override of internal controls, including evaluating whether there was evidence of bias by the directors that represented a risk of material misstatement due to fraud.

#### Key audit matters

- Material uncertainty related to going concern
- Valuation of intercompany loans receivable

#### Materiality

- Overall materiality: £4,067,500 (2022: £5,225,000) based on 1% of total assets.
- Performance materiality: £3,050,625 (2022: £3,919,000).

### The scope of our audit

As part of designing our audit, we determined materiality and assessed the risks of material misstatement in the financial statements.

### Key audit matters

Key audit matters are those matters that, in the auditors' professional judgement, were of most significance in the audit of the financial statements of the current period and include the most significant assessed risks of material misstatement (whether or not due to fraud) identified by the auditors, including those which had the greatest effect on: the overall audit strategy; the allocation of resources in the audit; and directing the efforts of the engagement team. These matters, and any comments we make on the results of our procedures

thereon, were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

In addition to going concern, described in the Material uncertainty related to going concern section above, we determined the matters described below to be the key audit matters to be communicated in our report. This is not a complete list of all risks identified by our audit.

Material uncertainty related to going concern is a new key audit matter this year. Otherwise, the key audit matters below are consistent with last year.

We have obtained management's model and verified the mathematical accuracy of calculations used.</p> <p>Overall, we conclude with the assessment that management have made and that there is no indication of material impairment.</p>

### How we tailored the audit scope

We tailored the scope of our audit to ensure that we performed enough work to be able to give an opinion on the financial statements as a whole, taking into account the structure of the company, the accounting processes and controls, and the industry in which it operates.

The entity consists of one operating segment and is managed from a single location based in the United Kingdom.

### The impact of climate risk on our audit

As part of our audit we made enquiries of management to understand the extent of the potential impact of climate risk on the company's financial statements, and we remained alert when performing our audit procedures for any indicators of the impact of climate risk. Our procedures did not identify any material impact as a result of climate risk on the company's financial statements.

### Materiality

The scope of our audit was influenced by our application of materiality. We set certain quantitative thresholds for materiality. These, together with qualitative considerations, helped us to determine the scope of our audit and the nature, timing and extent of our audit procedures on the individual financial statement line items and disclosures and in evaluating the effect of misstatements, both individually and in aggregate on the financial statements as a whole.

Based on our professional judgement, we determined materiality for the financial statements as a whole as follows:

<i>Overall company materiality</i>	£4,067,500 (2022: £5,225,000).
<i>How we determined it</i>	1% of total assets
<i>Rationale for benchmark applied</i>	The entity functions to service group financing requirements. Therefore, using total assets as a benchmark is appropriate.

We use performance materiality to reduce to an appropriately low level the probability that the aggregate of uncorrected and undetected misstatements exceeds overall materiality. Specifically, we use performance materiality in determining the scope of our audit and the nature and extent of our testing of account balances, classes of transactions and disclosures, for example in determining sample sizes. Our performance materiality was 75% (2022: 75%) of overall materiality, amounting to £3,050,625 (2022: £3,919,000) for the company financial statements.

In determining the performance materiality, we considered a number of factors - the history of misstatements, risk assessment and aggregation risk and the effectiveness of controls - and concluded that an amount at the upper end of our normal range was appropriate.

We agreed with the Kemble Water Holdings Limited Board that we would report to them misstatements identified during our audit above £406,750 (2022: £522,500) as well as misstatements below that amount that, in our view, warranted reporting for qualitative reasons.

## **Reporting on other information**

The other information comprises all of the information in the Annual Report other than the financial statements and our auditors' report thereon. The directors are responsible for the other information. Our opinion on the financial statements does not cover the other information and, accordingly, we do not express an audit opinion or, except to the extent otherwise explicitly stated in this report, any form of assurance thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated. If we identify an apparent material inconsistency or material misstatement, we are required to perform procedures to conclude whether there is a material misstatement of the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report based on these responsibilities.

With respect to the Strategic report and Directors' report, we also considered whether the disclosures required by the UK Companies Act 2006 have been included.

Based on our work undertaken in the course of the audit, the Companies Act 2006 requires us also to report certain opinions and matters as described below.

### **Strategic report and Directors' report**

In our opinion, based on the work undertaken in the course of the audit, the information given in the Strategic report and Directors' report for the year ended 31 March 2023 is consistent with the financial statements and has been prepared in accordance with applicable legal requirements.

In light of the knowledge and understanding of the company and its environment obtained in the course of the audit, we did not identify any material misstatements in the Strategic report and Directors' report.

## **Responsibilities for the financial statements and the audit**

### **Responsibilities of the directors for the financial statements**

As explained more fully in the Statement of directors' responsibilities in respect of the financial statements, the directors are responsible for the preparation of the financial statements in accordance with the applicable framework and for being satisfied that they give a true and fair view. The directors are also responsible for such internal control as they determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the directors are responsible for assessing the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the company or to cease operations, or have no realistic alternative but to do so.

### **Auditors' responsibilities for the audit of the financial statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud, is detailed below.

Based on our understanding of the company and industry, we identified that the principal risks of non-compliance with laws and regulations related to the Listing Rules, and we considered the extent to which non-compliance might have a material effect on the financial statements. We also considered those laws and regulations that have a direct impact on the financial statements such as UK corporation tax legislation and the Companies Act 2006. We evaluated management's incentives and opportunities for fraudulent manipulation of the financial statements (including the risk of override of controls), and determined that the principal risks were related to the posting of journal entries to manipulate the financial results in the year. We have also considered the risk of management bias in forming its significant accounting judgements or estimates and in the related disclosures. Audit procedures performed by the engagement team included:

- Discussions and inquiries of group management, internal audit function and legal counsel, including consideration of known or suspected instances of non-compliance with laws and regulation and fraud;
- Evaluation of management's controls designed to prevent and detect irregularities;
- Challenging assumptions made by management in determining significant accounting estimates and judgments in particular in relation to the valuation of intercompany loans receivable. We have tested significant accounting estimates and judgments to supporting documentation, considering alternative information where appropriate along with considering the appropriateness of the related disclosures in the financial statements;
- Identifying and testing a sample of journal entries throughout the whole year, which met our pre-determined fraud risk criteria;
- Reviewing minutes of meetings of those charged with governance and reviewing internal audit reports; and
- Incorporating elements of unpredictability into the audit procedures performed.

There are inherent limitations in the audit procedures described above. We are less likely to become aware of instances of non-compliance with laws and regulations that are not closely related to events and transactions reflected in the financial statements. Also, the risk of not detecting a material misstatement due to fraud is higher than the risk of not detecting one resulting from error, as fraud may involve deliberate concealment by, for example, forgery or intentional misrepresentations, or through collusion.

Our audit testing might include testing complete populations of certain transactions and balances, possibly using data auditing techniques. However, it typically involves selecting a limited number of items for testing, rather than testing complete populations. We will often seek to target particular items for testing based on their size or risk characteristics. In other cases, we will use audit sampling to enable us to draw a conclusion about the population from which the sample is selected.

Under the Companies Act 2006 we are required to report to you if, in our opinion:

- we have not obtained all the information and explanations we require for our audit; or
- adequate accounting records have not been kept by the company, or returns adequate for our audit have not been received from branches not visited by us; or

- the financial statements are not in agreement with the accounting records and returns.

We have no exceptions to report arising from this responsibility.

## Accounting policies

The following accounting policies have been adopted in the preparation of these financial statements. They have been applied consistently in dealing with items considered material, except as noted below:

### General information

Thames Water (Kemble) Finance plc ("the Company") is a public limited company, limited by shares, incorporated and domiciled in the United Kingdom under the Companies Act 2006. The address of the registered office is Clearwater Court, Vastern Road, Reading, Berkshire, RG1 8DB. The Company's principal activity is to raise finance on behalf of its immediate parent undertaking Kemble Water Finance Limited ("KWF").

### Statement of compliance with International Financial Reporting Standards

The financial statements have been prepared in accordance with UK-adopted international accounting standards and with the requirements of the Companies Act 2006 as applicable to companies reporting under those standards.

### Basis of preparation

The financial statements for the year ended 31 March 2023, set out on pages 16 to 33, have been prepared on the going concern basis, under the historical cost convention, as modified by the revaluation of certain financial assets and liabilities at fair value, and in compliance with the Disclosure and Transparency Rules ("DTR") issued by the Financial Conduct Authority.

Certain cash flows related to the Company are transacted by fellow group companies on behalf of the Company. The directors have assessed that the Company is the principal in these transactions and the role of other group's companies is for administrative purposes only. As such the Company presents all cash flows related to the company in these financial statements in line with IAS 7.

### Going concern

The TW(K)F Directors have considered the nature of the business and do not expect this to significantly change over the next 12 month period, recognising it is a special purpose financing entity with no business operations other than raising external funding for its Guarantor and direct holding company, Kemble Water Finance Limited ("KWF"). TW(K)F relies on Kemble Water Holdings Limited ("KWH"), the ultimate parent company, for ongoing support.

KWH has confirmed that it will continue to provide support to the Company to enable it to meet its liabilities as they fall due for a period of at least twelve months from the date of signing of these financial statements and on this basis the Directors of TW(K)F have adopted the going concern basis in preparing these financial statements.

In making the assessment of KWH's ability to provide the support as required, the Directors of TW(K)F have considered the material uncertainty in relation to the going concern assessment in KWH related to (i) the inability to refinance the £190 million loan facility with KWF (an indirect subsidiary of KWH and the parent company of TW(K)F) before April 2024 and (ii) the breach of the Post Maintenance Interest Cover ("PMICR") covenant for KWF Group in the event of a severe but plausible downside scenario and the availability of or certainty of potential remedies. The KWH Directors have also considered the various options to resolve such uncertainties at KWF which include but are not limited to various refinancing actions which could include additional support from shareholders on a temporary basis. Remedies to address potential non-compliance of the PMICR covenant include utilisation of the associate equity cure via shareholder contributions which underpin the business plan of Thames Water Utilities Limited and the amendment or refinancing of the associated loan facility, both of which require the agreement and support of the loan counterparty. These material uncertainties relating to refinancing requirements and covenant compliance of the KWH Group may cast significant doubt about the ability of TW(K)F to continue as a going concern.

The Directors of TW(K)F, have considered it appropriate to place reliance on the support from KWH despite the uncertainties noted above, based upon a review of the KWH Group's budget, business plan and investment programme, together with the cash and committed borrowing facilities available. The TW(K)F Directors also took into account potential contingent liabilities and other risk factors in making their assessment.

For these reasons, the TW(K)F Directors' have a reasonable expectation that the Company will have access to adequate resources to continue in operational existence for a period of at least 12 months from the date of these financial statements and have therefore concluded that the financial statements should be prepared on a going concern basis. However, the financial statements do not include the adjustments that would result if the Company were unable to continue as a going concern.

## Accounting policies (continued)

### New accounting policies

The accounting policies adopted in the preparation of these financial statements are consistent with those of the previous financial year.

### Finance income and finance expense

Finance income represents the recharge to KWF of costs and interest incurred by the Company in respect of the raising of finance on KWF's behalf including a margin based on the terms of the relevant intercompany loan.

The Company's finance expense represents the interest costs on loans and borrowings, recognised on an accruals basis, along with the amortisation of bond fees.

### Non-derivative financial instruments

A financial instrument is any contract that gives rise to a financial asset in one entity and a financial liability or equity instrument in another entity. Non-derivative financial instruments comprise cash and cash equivalents, intercompany loans receivable, borrowings, other financial assets, and amounts payable in respect of group relief.

#### *Cash and cash equivalents*

Cash and cash equivalents – cash at bank and in hand are held at amortised cost and include cash on hand and deposits held at call with financial institutions.

#### *Intercompany loans receivable*

Intercompany loans issued to other group companies are initially recognised at fair value plus transaction costs that are directly attributable to the acquisition of the financial asset. They are subsequently measured at amortised cost using the effective interest rate method, less any provision for impairment. The amortisation is included within finance income in the income statement and is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate.

#### *Borrowings*

Borrowings are financial liabilities recognised initially at fair value less attributable transaction costs. Subsequent to initial recognition these are stated at amortised cost using the effective interest rate method. The amortisation is included within finance costs in the income statement and is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate.

#### *Other financial assets*

Other financial assets include amounts owed by immediate parent company KWF and is recognised at amortised cost using the effective interest rate method.

#### *Amounts payable in respect of group relief*

Amounts payable in respect of group relief represents amounts owed for the benefit of tax losses received from other entities within the Group.

## Accounting policies (continued)

### Embedded derivatives

Where a contract includes terms that cause some of its cash flows to vary in a similar way to a derivative financial instrument, that part of the contract is considered to be an embedded derivative. Embedded derivatives are separated from the host contract and measured at fair value with gains and losses taken to the income statement if:

- (b) the risks and characteristics of the embedded derivative are not closely related to those of the host contract; and
- (c) the contract is not carried at fair value with gains and losses reported in the income statement.

In all other cases embedded derivatives are accounted for in line with the accounting policy for the contract as a whole.

As at 31 March 2023, no embedded derivatives were recognised (31 March 2022: none).

### Fair value measurement

The Company measures financial instruments at fair value at each financial reporting date for disclosures. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value reflects the non-performance risk.

### Offsetting financial instruments

Financial assets and financial liabilities are offset and the net amount reported in the statement of financial position if there is currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis or to realise the assets and settle the liabilities simultaneously. During the year ended 31 March 2023, no amounts were offset in the financial statements (2022: £nil).

### Impairment of financial assets

There is an annual impairment review for intercompany receivables which assesses the ability of the entity to pay them based on a multi-factor analysis including the counterparty credit score, past history of default, current financial performance of the counterparty and potential future changes to the counterparty.

### Taxation

Tax on the profit or loss for the year comprises current and deferred tax, and is recognised in the income statement.

#### *Current taxation*

Current tax is the expected tax payable or receivable on the taxable income or loss for the year, using tax rates enacted or substantively enacted at the balance sheet date, and any adjustments to tax payable in respect of previous years.

Taxable profit differs from the profit on ordinary activities before tax as reported in the income statement because it excludes items of income or expense that are taxable or deductible in other years. This includes the effect of tax allowances and further excludes items that are never taxable or deductible.

#### *Deferred taxation*

Deferred tax is the tax expected to be payable or recoverable on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit, and is accounted for using the balance sheet liability method. Deferred tax is measured on a non-discounted basis using tax rates enacted or substantively enacted at the balance sheet date and that are expected to apply in the year when the deferred tax asset is realised or the deferred tax liability is settled.

Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised only to the extent that it is probable that sufficient future taxable profits will be available against which deductible temporary differences can be utilised.

### Taxation (continued)

#### *Deferred taxation (continued)*

Deferred tax assets and deferred tax liabilities are offset when there is a legally enforceable right to set off tax assets against tax liabilities and when they relate to income taxes levied by the same taxation authority and the Company intends to settle its current tax assets and liabilities on a net basis.

### Future standards and amendments

#### *IFRS 17 'Insurance Contracts' impact assessment*

IFRS 17 'Insurance Contracts', which replaces IFRS 4 'Insurance Contracts', establishes new principles for the recognition, measurement, presentation, and disclosure of insurance and reinsurance contracts and is mandatory for annual reporting periods beginning on or after 1 January 2023. This standard is not expected to have a material impact on the entity in the current or future reporting periods.

### Significant accounting judgements and key sources of estimation uncertainty

The preparation of annual financial statements requires the Company to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expense. Actual results may differ from these estimates.

The Directors do not consider there to be any critical judgements or estimates in applying accounting policies that have a significant effect on the amounts recognised in the current and future financial statements.

## Notes to the financial statements

### 1. Auditors' remuneration

The remuneration of the auditors, PricewaterhouseCoopers LLP, was borne by Thames Water Limited and was not recharged to the Company in both the current and preceding financial year. The total amount payable relating to the Company was £20,865 (2022: £19,500). This consists of £18,190 of statutory audit fees (2022: £17,000) and £2,675 (2022: £2,500) of other assurance related services.

### 2. Employees and Directors

#### Employees

The Company had no employees during the year (2022: none).

#### Directors

The Directors received no remuneration in respect of their services to the Company, as none were qualifying services, in both the current and preceding financial year. There were no retirement benefits accruing in either the current or preceding financial year. Directors' remuneration costs are borne by other members of the Kemble Water Group of Companies and no recharge is made to the Company for their services.

### 3. Segmental analysis

The Company's income and results arise solely in the United Kingdom and are attributable to one principal activity of the Company, being the raising of finance and subsequent lending of debt to KWF. Consequently, the Directors review the financial information of the Company as a whole and therefore have not included segmental analysis within these financial statements.

During the year, £118.5 million was received from KWF as repayment of an intercompany loan together with accrued interest, and used to repay £115.1 million of external debt and £3.4 million of related interest.

- (iii) During the year ended 31 March 2021, the Company repurchased £59.9 million debt (out of the £175.0 million external debt due in 2022) at a £2.7 million premium, with the tender price taking into account the above market interest rate on the bond and its trading price prior to the announcement of the tender. The remaining £115.1 million was repaid when due in July 2022.
- (iv) The bonds issued by the Company are guaranteed by KWF and the bondholders benefit from security over the assets of KWF.

The Company is a financing subsidiary of KWF. Its principal activity is to ensure the liquidity needs of the group are met through continued access to the capital markets. Proceeds of funding activities are lent on to KWF. The above described financial assets relate to intercompany debt owed by KWF. There are no amounts past their due dates.

In March 2023, Fitch downgraded KWF's and the Company's senior secured debt rating to B (2022: B+) and KWF's Long-Term Issuer Default Rating to B with negative outlook (2022: B+ with negative outlook). In March 2023 Moody's affirmed the rating of the Company's senior secured debt at B1 and changed the outlook to negative (2022: B1 with stable outlook).

As the external debt issuance and rating is based on the performance of the guarantor, KWF, the directors believe it is acceptable to attribute the same internal rating to the back-to-back loan receivable.

At a Kemble Water Holdings Limited ("KWH") consolidated level an assessment has been performed to consider the recoverability of the loans payable by KWF to the Company under IFRS 9.

Paragraph B5.5.38 of IFRS 9 states that the maximum period over which expected impairment losses should be measured is the longest contractual period where an entity is exposed to credit risk. As the Company's intercompany loan receivables are considered repayable on demand for the purpose of this assessment, the expected credit losses are based on the assumption that repayment of the loan is demanded in full at the reporting date. Various scenarios have been considered in a multiple factor analysis performed at the reporting date with no expected credit loss on the Company's intercompany loan receivables from KWF identified. As such there is no concern over the recoverability of these receivables and the Directors do not consider that there is any need to recognise an impairment provision, with the expectation that the intercompany amount will be materially recovered. This assessment has been made assuming capital markets continue to operate under normal market conditions.

Supporting and consistent with the above assessment, during the year £118.5 million was received from KWF as repayment of an intercompany loan together with accrued interest, and used to repay £115.1 million of external debt and £3.4 million of related interest (see Note 7 Intercompany loans receivable on page 26 for more details). As such given there is no specific concern over the ability to pay the external liabilities from which these intercompany receivables have arisen and a low probability of other events occurring that could lead to an impairment, the directors do not consider that there is any need to book an impairment provision and expect to materially recover the intercompany receivables.
